World Economic Forum International non-profit organization that promotes public debates on global issues. Its objective is sustainable development, the constant improvement of public and private organizations and the progress of society. It promotes the concept of Conscious Capitalism and the Fourth Industrial Revolution that today are pillars of corporate application around the world. And its discussions have addressed fundamental issues of global concern, such as international conflicts, poverty, environmental problems, and their possible solutions. In the last 10 years, emphasis has been placed on issues such as new geopolitical dynamics, the Fourth Industrial Revolution, globalization, climate change, sustainability and rebuilding political trust at the international level.	In 2025, the World Economic Forum (WEF) focused its energy transition agenda on two fronts. At Davos, where the Chairman of ISA's Board of Directors participated, energy was one of the central themes — with a stronger emphasis than in previous years on energy security, rising demand, and the role of energy as an enabler of economic development, with artificial intelligence (AI) and United States energy policy as cross-cutting axes of the debate. In parallel, the WEF published in June its flagship report <i>Fostering Effective Energy Transition 2025</i>, developed in partnership with Accenture, whose Energy Transition Index recorded an annual improvement of 1.1% in the global average — more than double the pace of the preceding three years — while cautioning about persistent vulnerabilities, given that global energy demand grew by 2.2%, driven by economic growth, heat waves, electrification, and the expansion of AI data centres. The report, which was shared with ISA, identified three systemic priorities to maintain progress on track: redefining energy security beyond traditional supply to encompass grid resilience and digital infrastructure; correcting capital imbalances, particularly in emerging economies; and resolving infrastructure bottlenecks — permitting processes, talent gaps, and grid capacity constraints — that currently impede the translation of technological readiness into tangible deployment. Similarly, through the association, regulatory advocacy efforts were coordinated, particularly against a bill repealing Article 114 of the Traffic Law, which would eliminate penalties for users driving without an activated TAG.
